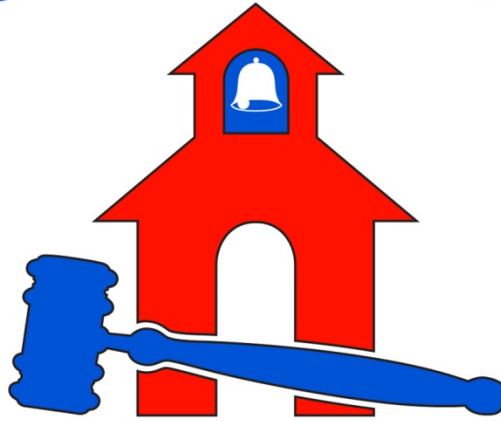


# School Board U



## Bringing Board Training to You

ASBSD's [School Board U](#) is our online training site for school board members.

ASBSD School Board U offers board members seven course options: School Board Governance, Fiscal Responsibility, Strategic Planning, a New Board Member Workshop, Ethical School Board Service, Board President & Superintendent Relationship and ASBSD Collective Bargaining Seminar.

Developed by the Georgia School Board Association and hosted by their affiliate, Crescance, School Board U allows school board members to **complete training individually, at your own pace and from the comfort of your home.**

If you are a new school board member or if your fellow board members have previously completed training in one of these courses, [School Board U](#) will cover your training needs and put you on an even knowledge plane with your fellow members.

*(Please note: ASBSD will continue to hold in-person training.)*

Veteran board members looking to review or gain new knowledge in Board Governance, Strategic Planning and/or Ethical School Board Service can also do so through ASBSD School Board U.

And, with the implementation of the state's new school funding formula, everyone could benefit from School Board U's revamped GAVEL Fiscal Responsibility course.

School board members seeking training will commit approximately 3-4 hours to the course they choose to complete. Courses don't just follow a lecture and read model, but rather feature interactive videos and activities to help engage trainees.

The cost of each course is \$100 per registrant, except the New School Board Member workshop and Ethical School Board Service courses which are \$50, the Collective Bargaining Seminar, which is \$125, and the Board President and Superintendent Relationship, which is free for individuals in those corresponding roles. Registration must be completed online by your district's business manager – similar to how registration is completed for other ASBSD events.

### **GAVEL – School Board Governance**

This workshop helps board members better understand their unique role in public education and public service. Board members will be introduced to education law, policy making, board-superintendent relationships, the difference between governance and management, collective bargaining, human resources, and board meeting procedures.

### **GAVEL – Fiscal Responsibility**

This workshop presents the basics on school district finances and helps board members understand school district fund accounting, the state's new funding formula, the taxes and levies utilized by districts, how the opt-out process works, what a school district budget entails and the school board's role in the internal financial controls of the district.

### **GAVEL – Strategic Planning**

This workshop helps board members identify the key elements of strategic planning and gets them started on writing a strategic plan for their school district. Board members will learn the importance of district level vision, mission, beliefs, and goals. Board members will learn the importance of data-driven decision making, the value of accountability in tracking student achievement, the importance of creating a board learning community, and the importance of developing a continuous improvement plan.

### **New School Board Member Workshop**

This is a course for new school board members. It will give new members a quick overview of responsibilities, expectations, and modes of operation of school board members. It will also outline some of the pitfalls of board membership, and guide members to the proper means to improve student achievement and learning. This course is based on the newly revised Code of Ethics for School Board members from the Associated School Boards of South Dakota (ASBSD) Policy Reference Manual. Some of the items from the Code of Ethics will be discussed separately, while others will be combined by subject matter or topic with similar items.

### **Ethical School Board Service**

This course is based on the older Code of Ethics for School Board members sample policy (now revised) from the Associated School Boards of South Dakota (ASBSD) Policy Reference Manual. Each of the 15 items from the Code of Ethics will be listed separately and expounded upon. The course outlines and underscores school board members' roles and responsibilities and expected ethical performance and behavior as a school board member. This course is recommended for new and veteran board members.

### **Board President & Superintendent Relationship**

This course covers aspects of the interaction like communication, building trust, and fostering success, among many other features, with assistance from Lead-Deadwood Superintendent Dr. Dan Leikvold and Board Member, and former President, Orson Ward.

### **ASBSD Collective Bargaining Seminar**

This course covers how districts must apply the new funding formula, the accountability requirements introduced by the new legislation and negotiating teacher salary and benefits.
