1. Call to Order - President Peterson

Information: 1.1 Good News -

3. Financial Items

Action: 3.1 Financial Reports through January 2017 - Matt Flett, CFO

Matt Flett reported as of January 31st the Association has received \$1,229,528.78 or 61.13% of our revenue budget and have expended \$1,171,065.03 or 58.23% of our expenditure budget. At this time last year, the Association had total revenue of \$1,256,561.96 or 65.33% of our revenue budget. While expenditures were at \$1,158,629.19 or 57.97% of our expenditure budget. We have a strong balance sheet and strong financial position. The Association is in good financial shape. Moved by Melissa Whipple, second Tom Farrell the financial report was approved as presented. Motion carried.

4. Reports

Information: 4.1 NSBA Report - Neil Putnam

Neil Putnam reported NSBA will be closely monitoring the new Secretary of Education as well as the appointment of the new Secretary of Agriculture. Monies appropriated for school nutrition is not even on the radar. He continued that NSBA will be monitoring the first 100 days of President Trump's term for direction.

5. Board Development

Information: 5.1 Input on ESSA accountability rules

Abby Javurek-Hurnig and Mary Staddick Smith from the Department of Education asked for input from the Board regarding the Every Student Succeeds Act, or ESSA. It was the reauthorization of the Elementary and Secondary Education Act, established in 1965. Key areas – 1. Accountability; 2. Assessment and Standards; 3. School Improvement and Student Support; 4. Data/Reporting; were discussed, questions asked and feedback provided.

Input will be funneled to the ESSA Accountability Work Group, the Committee of Practitioners, the Board of Education and the Department of Education, to be considered as the state's required plan is drafted. Once the plan is drafted (expected to be spring 2017), an official public comment period will be opened and additional feedback solicited.

6. Advocacy

Information: 6.1 Legislative Update – Board members received an update on legislative session, Dr. Pogany briefly touched on the following bills: House Bill 1110: revises certain provisions regarding school bus stop violations; House Bill 1170: amends the conflict of interest disclosure law; House Bill 1196: prohibits the unauthorized use of electronic listening or recording devices in classrooms; Senate Bill 92: changes the year a school district is required to bring general fund reserves down to a certain percentages from 2018 to 2020; Senate Bill 55: protects the teaching of certain scientific information – ASBSD opposes this bill; Senate Bill 85: permits exemption of certain students from academic assessment tests - ASBSD opposes this bill; Senate Bill 134: prohibits the use of public school resources in any political vote – ASBSD opposes the bill; Senate Bill 177: revises certain provisions for participation of home school students in certain interscholastic activities – ASBSD opposes this bill; House Bill 1109: prohibits the use of handheld electronic wireless devices by school bus drivers; House Bill 1133: requires a school district to adopt a policy to provide for students with specific learning disabilities, including dyslexia; Senate Bill 33: adjust the special education fund levy and disability level allocations; Senate Bill 35: adjusts the general education fund levy, average teacher salary target and overhead rate for additional salary and benefits costs. Dr. Pogany shared ASBSD legislative team meets daily for strategic planning. Discussion followed.
