ASBSD Board of Directors Meeting Wednesday, August 4, 2021 Denny Sanford Convention Center Sioux Falls, SD

- I. **Call to Order –** President Eric Stroeder called the meeting to order. Present were members: Pam Haukaas, Susan Humiston, Julie Schwader, Tanya Gray, Louann Krogman, Eric Stroeder, Lisa Snedeker, Duane Alm, Jamie Lindner, Nan Baker, Angie Ross, Shane Roth, Tom Farrell and Anita Peterson, Ellie Saxer joined the meeting following the Financial Reports. Absent were board members Garret Bischoff and Steve Kubik.
- II. Welcome and Introductions Dr. Pogany introduced new board members Jamie Lindner, Waverly-South Shore and Nan Baker, Sioux Falls to the board. He also acknowledged the elections of Susan Humiston and Tom Farrell to their positions on the ASBSD Board. Rapid City had not notified ASBSD of board member appointment to the ASBSD Board.

III. Good News

Pam Haukaas – Colome is fully staffed and ready for school to begin. New policy on medical marijuana has been discussed by their board.

Susan Humiston – The class of 2021 Valedictorian of Edgemont is a very humble girl from a family of limited means and has been accepted at the School of Mines. Everyone is so proud of her.

Julie Schwader – Howard School District is fully staffed and ready for new year. The district had success working with Tom Oster for filling positions.

Tanya Gray – Hired a superintendent and have a good team moving forward. Not fully staffed and planning continues for the new high school and elementary school that will be built off campus.

Louann Krogman – White River is not fully staffed and will be opening school with things back to normal. Summer camps for basketball and football have been held.

Eric Stroeder – Mobridge-Pollock is ready to start and have been working on improvements in the school. They too are not fully staffed.

Lisa Snedeker – Everyone is ready to be back to work and it's exciting to prepare for school.

Duane Alm – School will be on-site but virtual learning will be available. They are fully staffed. A Central High School student placed first at the National Business Leaders Conference.

Jamie Lindner – Waverly-South Shore board members have been busy doing ASBSD training. Their district is not fully staffed for school.

Nan Baker – Nan thanked for the board for opportunity to be part of a team that focuses on children. Sioux Falls held ribbon cutting ceremony at new high school and middle school. They continue working on hiring staff to begin the school year. Return to learn with a mask recommendation on buses. Mother of 4-3 boys and one girl.

Angie Ross – Hill City is academically fully staffed, except for coaching. COVID money has been used for infrastructure and they will begin the school year as normal as they can.

Shane Roth – DeSmet hired a band teacher and they now are fully staffed. It closed at building that was built in 1960 and have built onto the high school. Things are going great in DeSmet and they too are trying to open school back to normal.

Tom Farrell – Madison Central is fully staffed as of this morning. He is thankful for help with policies as their back to school plans are changing. District still needs bus drivers.

Anita Peterson – Haakon (Phillip) is fully staffed. Auditorium has had a face lift with new paint and lights. In the process of building a bus barn.

Wade Pogany – Dr. Pogany welcomed and thanked Nan Baker and Jamie Lindner for their interest in becoming ASBSD Board members. Kudos and thank you to his staff for all the work on Convention. Wade also thanked Jessica Filler for all of her work on the medical marijuana policy and other policies relating to COVID.

- **IV.** Approval of Minutes Moved by Tom Farrell, second by Tanya Gray to correct the minutes of the April 16-17, 2021 minutes by changing Tom's Good News report that Madison negotiations lasted 4 ½ days not 4 and ½ hours as reported. Motion to approve with correction carried.
- V. Reorganization of the Board Dr. Pogany reminded the board that at the January meeting a motion by Susan Humiston, second by Julie Schwader to move forward with the continuation of current executive committee and approve them as the slate of officers at our annual meeting was approved. The Constitution and By-Laws require that at our annual meeting we officially approve the slate of officers. Moved by Susan Humiston and second by Pam Haukaas to approve the officers remain in their current positions. Motion carried. He again welcomed Nan Baker to fill the position of Todd Thoelke, Jamie Lindner to complete the term of Denise Lutkemeier, Susan Humiston and Tom Farrell upon their re-elections to the board
- VI. Finance VI.A Financial Report Holly Nagel reported that June 30th marks the end of the 2021 fiscal year and the financial report is based on the financial performance of ASBSD at that time. We ended the fiscal year with revenue of \$2,587,943.11 which is 123.11% or \$485,786.17 over our revenue budget. This is a revenue increase of \$336,335.22 from FY 20.

FY 21 expenditures were \$1,738,927.93 which is 85.5% or \$293,932.07, less than expenditure budget. This is a decrease in spending of \$192,036.73 from FY20.

After all year-end entries are completed, the Association increased the overall Net Position on the balance sheet by \$337,848.

The Unassigned Net Position of the Association at the end of Fiscal Year 2021 is \$2,322,164 which is 114 percent of the FY 2021 expenditure budget of \$2,032,860. The Unassigned Net Position decreased by \$764,900 from \$3,087,064 at the end of FY 2020 to \$2,322,164 at the

end of FY 2021. The difference between revenue and expenditures will not directly tie out to Unassigned Net Position.

The Net Investment in Capital Assets increased in \$826,413.79. This is due to November purchase of the 3rd Floor Condominium from TDK&E. This completes full ownership of the building at 306 E. Capitol Avenue. The purchase was completed using cash funds from the money market account which caused the reduction in Unassigned Fund Balance. There was neither an increase in long-term liability nor a reduction in mutual fund investments. The TDK&E mortgage of \$218,651 was paid in full and the long-term asset of buildings was increased by the full value of \$1,120,464.

ASBSD continues to have a strong balance sheet and financial position. The Association has increased the potential revenue with the purchase of the third floor. Tieszen Law Office has completed a five-year lease agreement with option to renew twice for the 3rd floor east side.

Moved by Tanya Gray, second by Louann Krogrman to accept the financial report as presented. Motion carried.

Finance VI.B Protective Trust Update – Holly Nagel presented the Protective Trust Report. She reported the health fund continues to be strong with a total of 78 member districts and the health assessment payments paid in full.

The Workers Comp pool continues to do well with 76 member districts.

Property Liability members continue to work hard to reduce claims. Webinars and open claims meetings have been well received.

Moved by Duane Alm, second by Anita Peterson to accept the Protective Trust Update as presented. Motion carried.

- VII. Conflict of Interest Policy Dr. Pogany shared in accordance with ASBSD Policy BOF Board of Directors need to complete and sign a conflict of interest statement. Each Board member shall annually sign an acknowledgement of a conflict of interest policy, and update it.
- VIII. Gift Policy As part of the conflict of interest policy, ASBSD Board requires that directors, officers and employees decline accepting certain gifts. Officers, board members and employees must read and sign the Gift Policy statement. Copies of the two policies were provided and board members read and signed statements.
