

## BOARD DEVELOPMENT



### School Board Governance

Helps board members better understand their unique role in public education and public service.

- Understand their place as governing bodies in our form of government;
- Understand the board's legal responsibilities and policy development;
- Understand meeting protocols and procedures;
- Understand how to support human resource systems and their role in negotiations, hiring and terminations;
- Understand the importance of operating as a governance leadership team.

### Fiscal Responsibility

Offers insight into school finance concepts, district budgets and internal control.

- Understand basic school finance concepts;
- Understand how the state's school finance formula works;
- Understand the funds authorized by South Dakota law;
- Understand budget preparation and school revenues;
- Understand the components of internal financial control.


### Strategic Planning

Details the school board's leadership role in improving student achievement.

- Understand the importance of the district's vision, mission, beliefs and goals;
- Understand the basics of data-driven decision making;
- Understand the value of accountability in tracking student achievement;
- Understand the importance of creating a board learning community and being an advocate for students;
- Understand the importance of developing a continuous improvement plan.

## The Benefits of GAVEL

- Make decisions at the board table that are in the best interest of students;
- Form good working relationships with other board members and the administration as a governance team;
- Understand and avoid crucial mistakes when dealing with legal issues;
- Fulfill the board's responsibilities to ensure a fiscally responsible school system;
- Work within the board's role with respect to personnel issues, including collective bargaining, hiring and terminations;
- Clarify when the board should make a decision and when it should defer to administration;
- Work effectively with the community in areas that range from advocacy to dealing with citizen concerns;
- Value the vision, mission and distinct-level goals as a way to improve student achievement;
- Understand how ASBSD services and staff can assist school boards.

**New School Board Members**— Find out how to make the most of your time on the board and how to avoid common mistakes.


**First-Term Board Members**— Reinforce what you've learned on the board and fill in the gaps so you can be a more effective board member.


The Yankton School Board became the first board to combine both online and face-to-face trainings to become GAVEL certified and continues to utilize the training with new members.



## ASBSD Board Recognition Program

The ASBSD Board Recognition Program is designed to recognize school boards for their dedicated and ethical service to the students of South Dakota. This program will recognize board members' participation in outside activities, board development and training, and demonstrated leadership at various areas and levels.

### ALL — Act, Learn, Lead

**ACT** — Activities in this category demonstrate participation at various board functions

**LEARN** — Activities in this category center around board member training opportunities board members have attended and completed

**LEAD** — Activities in this category focus on leadership events or activities where board members take on a leadership role or participate in leadership training

### How does the program work?

By participating in ASBSD activities, training opportunities and demonstrating leadership at the local, state and national level, board members accumulate points to achieve awards. For each level of award, Gold, Silver, and Bronze, point totals are counted in Act, Learn and Lead categories. In order to qualify for any board award, some points must be earned in all three.

- **Gold** — 500 cumulative point total
- **Silver** — 350 cumulative point total
- **Bronze** — 250 cumulative point total
