

# Meth Awareness and Active Shooter Training Registration Form

**Course Description:** The City of Beresford in conjunction with the SD Division of Criminal Investigation and the SD Highway Patrol will be hosting a free clinic to help employees of the various government agencies in Bon Homme, Charles Mix, Clay, Hutchison, Lincoln, McCook, Turner and Union, Yankton, Counties recognize meth labs and the waste left behind as well as provide information to increase knowledge regarding the planning process for encounters with an active shooter.

**Presenters:**

**Mike Hockett with the South Dakota Division of Criminal Investigation** will lead this informative Meth Awareness session and provide information on Clandestine Methamphetamine Awareness including what to look for and the hazards involved with manufacturing meth.

**Sgt. Rob Mayer, South Dakota Highway Patrol** will lead a session on active shooters which will include content on past incidences as well as provide different tools and tips on how to respond during these types of situations.

**Date and Time:** Two identical sessions will run in the morning and afternoon of **July 13, 2016**. The first session will be 9:00-11:30 AM and the second session will be 1:30-4:00 PM. Both sessions will cover the same information, so attendees will only need to go to one of the sessions.

**Location:** Both sessions will be held at the **Bridges Event Center, (Beresford Golf Course Club House) located at 601 S. 7<sup>th</sup> Street**. When exiting off I-29, proceed East on SD Hwy 46 to 7<sup>th</sup> Street and then South on 7<sup>th</sup> Street to the Bridges Event Center. If coming from the East on SD Hwy 46, proceed West to 7<sup>th</sup> Street and then South to the Bridges Event Center. The High School will be to your left and the Bridges will be to your right. Feel free to park in the Bridges or the High School parking lot.
