**Support for New Principals: Common Questions Answered and Ideas Shared (Rooms 8, 9 & 10)**

SDASSP and SDAESP members will provide information for new or newer principals during an interactive session with discussion on important topics related to being a principal in South Dakota and an overview of state and regional principal organizations, an introduction of state board members, answers to common questions new principals have every year and an opportunity to connect with other principals.

**What Does the Future Hold for the New K-12 Funding System? (Rooms 11 & 12)**

Last legislative session brought a win for K-12 public schools with new money for teacher salaries, but it is not the end of the story. Learn about broader effects within the legislation and ponder the type of metrics public education will want to monitor to ensure this funding fix works for school districts, students and staff. The session will also “build a plan” to identify concerns and potential fixes in the new funding formula.

**School Board Member Roles, Rights and Responsibilities via the Code of Ethics (Room 13 & 14)**

This session will examine a school board member’s roles, rights and responsibilities through the Board Member’s Code of Ethics, when considering them as public officers versus private citizens. Closing the achievement gap between students who qualify for free or reduced price lunch and those who do not is not easy, but five districts in South Dakota did it – and kept closing it over six years! This session will explain the measures of gap-closure used and leaders from the districts will share their instructional and organizational practices that led to their success.

**Facebook Firings: Social Media and Free Speech for School Employees (Room 3)**

As of 2015, Facebook has over 1.4 billion users worldwide and Twitter close to 290 million. These on-line social networks are rapidly becoming a part of everyday life in South Dakota’s public school districts, where employees may comment in conversation to each other, their family, or friends that they dislike their students or supervisors, or disagree with certain school practices. This presentation will examine how the courts have applied First Amendment principles to these various types of social media cases.

**IDEA Maintenance of Effort Compliance (Room 2)**

Recent changes to the Individuals with Disabilities Education Act’s local maintenance of effort (MOE) requirement affect how the MOE comparison year is determined, and how school districts distinguish special education expenditures between state and local funds for MOE compliance.

**How to help your students avoid just “Barking at Text” – Developing the Common Core anchors of reading comprehension (Room 1)**

Samuels (2007) referred to students who could read well orally but who have poor comprehension as “barking at text.” The panel will discuss their own data and how they have improved student reading comprehension in their schools. Variations with implementation procedures will be explored in relation to improved reading comprehension of complex text.

**School Facility Physical Security (Rooms 8, 9 & 10)**

The session will also explore common threats to schools, including active shooter events and training resources in the state of South Dakota that are available to schools.

**Managing your Cloud Identity (Rooms 11 & 12)**

**The Open Meetings Law: Changes from the 2016 Legislature and Reminders of Existing Law (Rooms 13 & 14)**

**Rolling Out Standards-Based Learning & Reporting (Rooms 8, 9 & 10)**

**ESSA and Accountability: What We Know and Where We're Headed (Rooms 8, 9 & 10)**

Exact details of the Every Student Succeeds Act's accountability provisions, effective for the 2017-18 school year, remain murky. Together with stakeholders, the South Dakota Department of Education is moving forward with determining how to best implement the law for our schools and students. This session will cover highlights of the new law's accountability requirements, including opportunities for flexibility and will give insight as to where the state's ESSA work groups are headed with recommendations.
