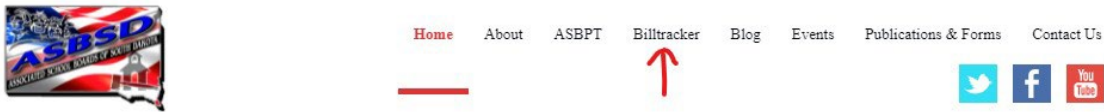


Navigating ASBSD's Bill Tracker

The [ASBSD Bill Tracker page](#) provides visitors with ASBSD's positions on, summary for and the location and most recent date of action on bills we're tracking during legislative session. Use the following steps to navigate the [Bill Tracker page](#):

1. On the ASBSD homepage (www.asbsd.org), click the [Bill Tracker link](#) located on the top right of the page:



OR click the Bill Tracker link found under the Services header in the Sitemap list located at the bottom of the page:



2. On the [Bill Tracker page](#) you'll find a list of all the bills and resolutions being tracked by ASBSD. Five columns provide information on each piece of legislation, columns include: Bill Number, ASBSD Summary, Position, Current Location and Date of Last Update:
