- I. Call to Order President Garret Bischoff called the meeting to order at 12:00 p.m. Present were board members, Louann Krogman, Eric Stroeder, Garret Bischoff, Duane Alm, Pam Haukaas, Susan Humiston, Shane Roth, Julie Schwader, Anita Peterson, Marc Murren, Jamie Lindner, Lisa Snedeker, Tanya Gray, Dan Cronin, Jamie Clapham and Amber Vogt. **Susan Humiston** – Edgemont district is having a "baby boom" with 4 teachers expecting babies this spring. The volleyball team had a great season and on a personal note her youngest daughter is also having a baby in March.

The district received a three million dollar grant for mental health, opened a new middle school building and last but not least Central won its first homecoming football game in three years.

**Dan Cronin** – Pierre had success of trying to win its straight 8<sup>th</sup> football title and unfortunately they came up a little short this year. Tests scores are coming up and superintendent and legislative team are meeting with legislators.

**Duane Alm** – Aberdeen Lincoln Elementary was named a Blue Ribbon School. The Veteran's Day Assembly was very well attended and public commented on how well behaved the students were. Aberdeen area has 5 new legislators and they have been asked what their thoughts are on: Governors Budget; support for state aid and support for public education.

## V. Financial Report

**XI.A. Financial Report through October 2024 –** Holly Nagel, CFO, reported October 31<sup>st</sup> marks the end of the first four months of the fiscal year. As of October 31<sup>st</sup>, we have received \$1,065,986.96 or 45.32%, of our revenue budget and expended \$637,371 or 27.43% of our expenditure budget.

At the same time last year, the Association had total revenue of \$760,963, or 33.78% of our revenue budget while expenditures were \$822,360 or 36% of our expenditure budget.

The Gains/Losses on Investments are the primary reason for the difference in revenue received from FY25 to FY24.

The Unassigned Net Position (Fund Balance) of the Association at the end of October is \$4,195,414 compared to last year at this time of \$3,735,227.

The difference between revenue and expenditures will not directly tie out to Unassigned Net Position. There are a few net Position categories that are adjusted at year-end to recognize pre-paid expenses and capital assets.

ASBSD continues to have a strong balance sheet and financial position which allows for adjustments should a revenue source be significantly decreased. Moved by Jamie Chapham, second by Anita Peterson to approve the financial report as presented. Motion carried.

**XI.B. ASBSD Financial Review –** Scott Currier from Palmer, Currier & Hoffert, LLP presented via zoom the ASBSD Financial Review. Moved by Marc Murren, second by Lisa Snedeker to accept as presented. Motion carried. Moved by Susan Humiston, second by Amber Vogt to approve the 990 and 990T as presented. Motion carried.

**XI.C Protective Trust Update –** Holly Nagel, CFO, briefly updated the board on Protective Trust activities.
